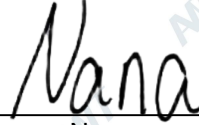

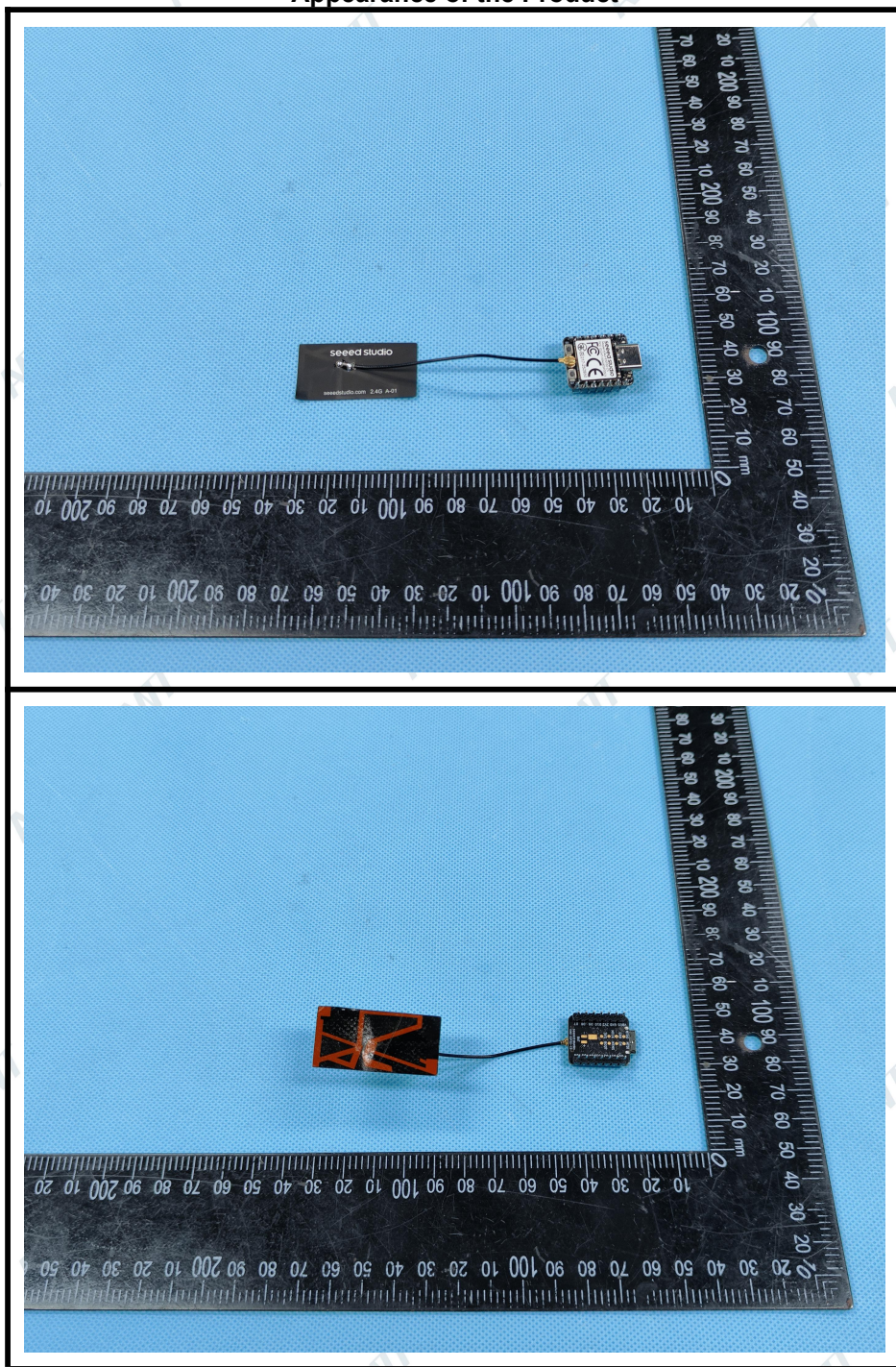

Appearance of the Product

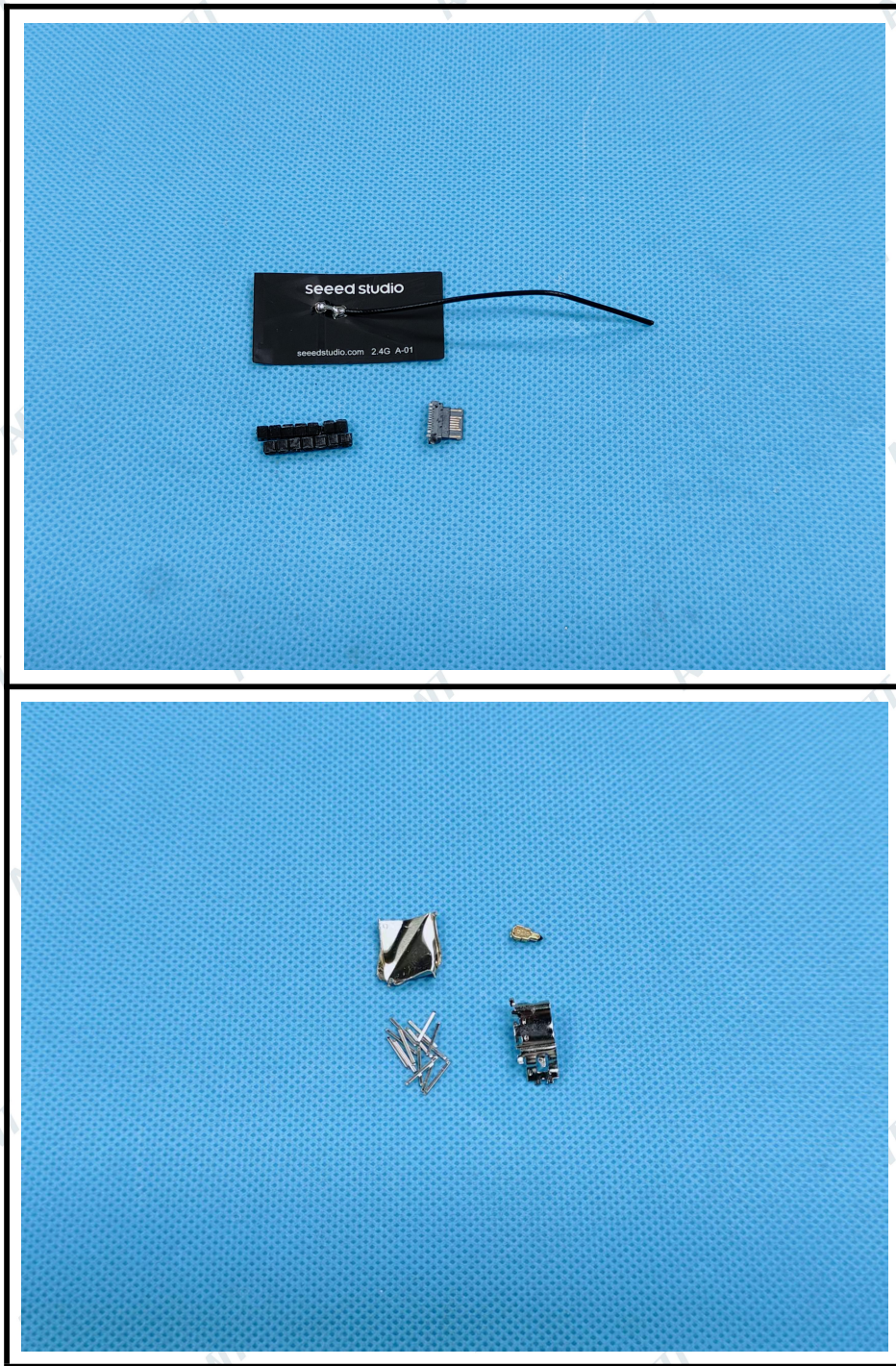

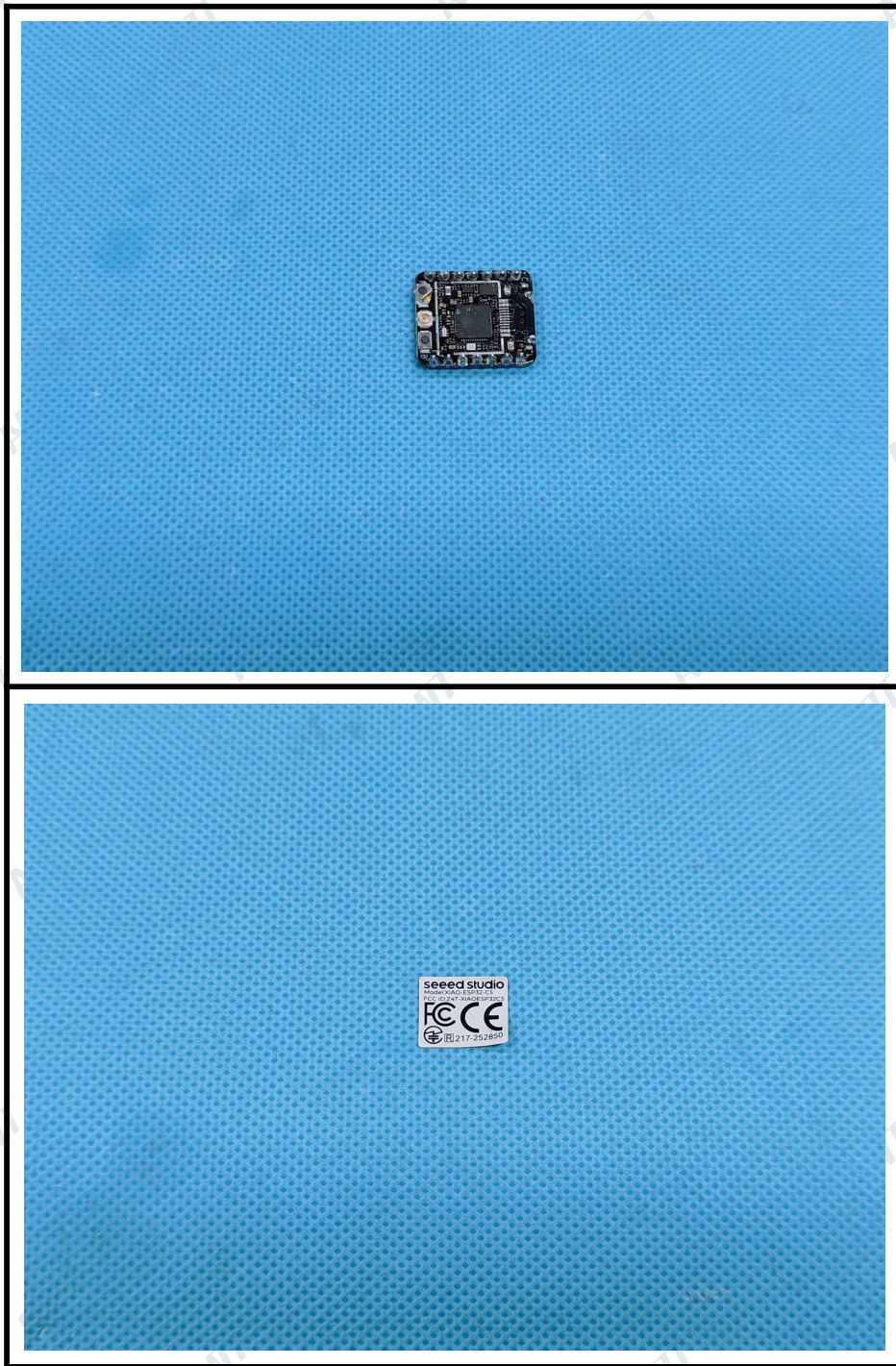

 - The product should apply to the RoHS Directive(Directive 2011/65/EU on the restriction of the use of certain hazardous substance in electrical and electronics equipment), the hazardous substance specification in the Directive should be controlled in the homogenous material of this product
- If a product has changed its product design, or materials or components employed, then the product should be reassessed and retested in accordance with the WEEE Directive for reuse/recycling/recovery assessment and RoHS for restricted/banned substances requirements.
